### **INTERN DUTIES**

- Under supervision, attend to telephone, email, and mail enquiries from clients including providing legal information on the telephone and legal advice through correspondence;
- Attending prison visits with solicitors to provide advice and information;
- Assist with the administration of client files and preparation for client interviews;
- Be aware of and comply with the Centre's Risk Management Guide, and the Centre's policies and procedures and attend volunteer induction;
- Undertake other duties as directed by the workers of the service.

### **SELECTION CRITERIA**

1. Currently enrolled in a Bachelor of Laws program at an Australian University/College with Administrative Law completed or commenced.
  2. Commitment to and understanding of social justice, particularly working with marginalised people.
  3. Advanced interpersonal communication skills with the ability to liaise with a broad range of disadvantaged people.
  4. Ability to work collaboratively, problem solve, and prioritise workload.
  5. Commitment to maintaining confidentiality.
  6. Commitment to a set 7.6 hour shift, two or three days a week during internship (depending on internship period).
